Mansfield Road – Speeding Cars: Traffic has been monitored on this route a number of times and offenders dealt with, ongoing monitoring

Priory Road – abandoning of cars: if an obstruction occurs call 101 or 7 day notice to remove will be actioned

Flowery Leys/One Stop : Parking by junction is an issue, ongoing monitoring

Alfreton Park: Undercover surveillance carried out, few issues to report, ongoing monitoring

School parking: Aware of issues and patrols carried out, ongoing monitoring

Lincoln Street: aware of the issues if dangerous parking persists contact Derbyshire County Council for their civil parking officers to patrol the area, ongoing monitoring

PC Gibbs reported that the crime figures for Alfreton had improved significantly in relation to shoplifting and that reported crimes are much lower than surrounding areas.
